

# Minutes of the 2016 ASDC AGM

27th September 2016
Hosted by The Royal Society
3.30 - 5.30 pm Chaired by Chas Bishop, ASDC Chair

### **Welcome and Thanks**

- The ASDC Chair Chas Bishop welcomed all members to the AGM, and thanked The Royal Society for hosting the conference.
- Chas Bishop invited all delegates to ask questions during the AGM.
- Chas Bishop thanked the ASDC CEO Dr Penny Fidler, the executive team and ASDC trustees for their work over the past year.

# CEO's summary of the year by Dr Penny Fidler

- Dr Penny Fidler thanked everyone for attending, and introduced the ASDC team.
- Dr Penny Fidler thanked all of the trustees for all their work over the year and delivered the CEO summary of the 2015/16 year and reported on the following highlights:
  - ASDC successfully secured £30 million for UK science centres through the Inspiring Science Capital Proposal to Government, now set up as the Inspiring Science Fund.
  - ASDC is currently running six national strategic programmes:

### National Astronaut programme - Destination Space

- Great national reach with 20 science centres.
- 491,244 participants of which 73,174 were school children.
- Two training academies.
- Space Agency capital funding awarded to centres.
- Penny Fidler passed on Tim Peake's thanks to all centres delivering Destination Space.

#### **The Crunch**

- Nine Centres taking part
- A year of activities to engage audiences with Our Food, Our Health, Our Planet.
- Aardman game was developed and has now been nominated for an award.
- The aim was to engage hard to reach community and family audiences.

# Hypatia (EU Horizon 2020 Project)

- Inspiring girls into science.
- ASDC are the UK lead partner.
- Penny Fidler invited delegates to speak to Shaaron Leverment if they wish to take part.

# **Cimulact (EU Horizon 2020 Project)**

• Citizens Dialogue on their visions for the future, to inform funding of EU Horizon 2020.

### **Explore Your Universe**

- 23 centres delivering the programme.
- The focus is inspiring audiences with physics, and engaging people with innovative STFC science.
- Phase 3 has just been agreed with STFC.
- Techniquest Glyndwr join the Explore Your Universe family.

#### Other activities

- Museum of the Moon has been developed by Luke Jerram in partnership with ASDC.
- ASDC are in discussions to create and run two new national programmes.
- Penny Fidler highlighted that ASDC main source of income is through Programmes



# Lobbying and Advocacy for the UK Science Centre and Engagement Sector

### **Inspiring Science**

- In January 2016 it was announced by Jo Johnson that the ASDC proposal to BIS to create an Inspiring Science Capital fund for Science Centres was successful.
- This would enable science centres for the first time for a decade to apply for capital funds to enhance what they could do.
- BIS (BEIS) will contribute £20 million
- The Wellcome Trust would contribute £10 million
- The Wellcome Trust would administer the fund.
- 14<sup>th</sup> October 2017 is the deadline for the preliminary applications

# Parliamentary Select Committee Science communication inquiry

- The Parliamentary Select Committee inquiry was held. ASDC submitted written evidence.
- Dr Penny Fidler was invited to give evidence on the panel of experts.
- An interesting question was asked by the Committee Chair 'do we have the policy of 'First do no harm'?

Penny Fidler thanked the ASDC team and funders and asked members if they had any questions. No questions were raised

# Approval of minutes of last AGM

- Terry O'Connor proposed that the minutes be approved
- Bryan Davies seconded
- Minutes approved

# Presentation and consideration of annual accounts for 2015/16

- Phil Winfield (ASDC Treasurer) presented the Treasurer's report and annual accounts 2015-16.
- Phil Winfield asked everyone to look at their delegate packs for the accounts and treasurer's report.

#### Income

- Phil Winfield noted that the total income for 2016-17 was £995,063
- Phil Winfield highlighted that project funding is the only way forward at present
- That there has been no core funding for ASDC for many years, with the exception of a small proportion received in membership fees
- Subscriptions have dropped however the ASDC are working to improve membership.

#### **Expenditure**

- Phil Winfield noted that the total expenditure for 2016-17 was £783,779.
- This directly correlates to an increase in project funding and delivery.

#### Reserves

- Total reserves for 2016-17 are £372,638.
- Phil Winfield highlighted that this was a year-end number and some of these funds are from projects that will continue in the following financial year.
- Reserves are monitored by the ASDC Board during quarterly Board meetings.
- The main reason the reserves are high at the moment as there is project money that has yet to be spent
- The ASDC Board look at the uncommitted reserves which look healthy

Phil Winfield noted that the ASDC team have a lot of work to do, and that none of this is covered by core funding. The project work enables this work to take place, however it is always an area that requires attention.

- Bryan Davies asked about uncommitted reserves
- Phil Winfield said they are 20K up from 2014/15 and continue to grow.
- Bryan Davies asked as the reserves have grown, where do you put your reserves as interest is so low?
- Terry O'Connor noted that there is a limit. When reserves drop to £100,000 a trigger point is reached which as a result the Board has a special focus on reserves.

# Core funding: How far has ASDC got in identifying any core funding and how likely is it?

- Penny Fidler responded that there was a core funding of £57,000 by BIS which ended in 2009
- Penny Fidler noted that it was relatively easy to get project funding compared with core funding and that if
  anyone knew funders that may be interested in providing core funding, she would be delighted to discuss
  this with any member.
- Penny Fidler noted that ASDC is in a good position with a very strong reputation for national delivery, and with, on occasions, funders approaching ASDC for projects.
- Chas Bishop noted that the current model currently works well but it is noted that if project funding does not come in it causes a concern.
- Bryan Davies, Catalyst suggested that during good times, ASDC should increase marketing and communications budget to try and highlight ASDC to future core funders.
- Chas Bishop recommended putting it on the agenda for the next board meeting.

# Terry O'Connor, STFC

Membership criteria: If the market is tight should we look at mergers and acquisitions of other membership organisations in order to deliver a single voice.

- Terry O'Connor suggested that we should be trying to help other organisations.
- Penny Fidler noted that Shaaron Leverment is now deputy CEO. The ASDC contact database is being revamped and we are now able to look at improving new relations and extending memberships. Shaaron Leverment is also the past BAP President.
- Shaaron Leverment noted that there are many smaller centres, and ASDC wants to address what the membership of ASDC means for them.
