

# Minutes of the 2015 ASDC AGM

## **Welcome and Thanks**

ASDC Chair Dr Teresa Anderson welcomed all members to the AGM, and thanked At-Bristol for hosting the conference. TA also thanked the ASDC trustees, CEO Dr Penny Fidler and executive team for their work over the past year.

# Presentation of the CEO's report by Dr Penny Fidler

Dr Penny Fidler thanked everyone for attending,

PF introduced the ADSC team

PF noted that Chris Godden would provide the finance report, but that ASDC had made a surplus in the 2014/15 financial year.

Dr Penny Fidler, ASDC CEO, reported on the highlights of the year, and ASDC National Projects. PF noted the following:

## National Astronaut Programme – funded by UK Space Agency

- National Astronaut Programme called Destination Space, reaching 20 science centres across the UK, project managed by James Summers
- 20 centres have been trained and are currently being equipped.
- PF thanked the National Space Centre for hosting the 2 training academies
- The project will reach 250,000 people across the UK
- 20 unique Sokol suit replica costumes have been made for this project

## **Explore Your Universe - Funded by STFC**

- Phase 1 156,880 people took part
- 50/50 gender split reached
- Range of kit delivered to 10 Phase 1 delivery partners
- Phase 2 10 additional delivery partner selected
- Trip to the CERN and the LHC took place in January 2015 for delegates from the 20 centres.

# Food and Drink Programme – The Crunch

- Working with Ardmann, At Bristol, Eden Project, Oxfam
- PF noted that Bristol is the European Green Capital 2015

PF asked the floor for questions regarding the programmes.

## **Lobbying update**

- Talked with David Willits and has been a huge support for an inspiring science capital fund for approximately £20 million.
- The Inspiring Science Capital fund was supported and approved, however due to a clerical misplacement the fund was given to the Universities and the AHRC



- An appeal was raised and the funding body has asked for ASDC to re submit a proposal which is now under consideration.
- There is information on the ASDC website under reports, more details are available
- PF asked the floor for questions
- PF has written articles about science centres for the parliamentary review
- Your Life is still running
- Sir Mark Walport is launching a second national tour
- PF noted the 'UK Science and Discovery Centres: Effectively Engaging Under Represented Groups' report and the great work people had put into the repost, noting that the practice is now being shared
- National education conference held at MOSI in February 2014

# **Financial Report, Audit Process and Approval of Accounts**

- Chris Godden (Finance Director) presented the Treasurers report and annual accounts 2014-15, noting that the majority of income is from projects which ASDC bids for competitively. The membership fee brings in only around 30K and this is the entire core funding contribution.
- Surplus of £33,000 than the deficit that was present last year.
- CG stated that the reason for figures was due to the timing of project funding
- Increase in alternative income including annual conferences and membership.
- The primary source of income continues to be project funding
- Hope that with 2015/2016 finances the company reserves should increase
- CG sought acceptance of the accounts
- Terry and Lianne proposed and seconded acceptance of the accounts
- CG sought a proposal for the re-appointment of Corrigan Associates as the auditors for the Independent examination.
- Chas and Terry proposed and seconded the reappointment of the auditors
- TA thanks Chris and his wife for their hard work
- Accounts approved by members present

# **Discussion: AOB**

#### **Regional Lobbying**

- Terry O'Conner noted that ASDC is a national organisation and made up of national trustees and centre members.
- TC noted that it is important that there is a national organisation due to the difficulty of funding. It is important as members to remind our MP's to overtly lobby for funding for Science.
- There are a lot of people out there, however regional involvement to actively lobby informal education within the next 1-2 weeks as
- The comprehensive spending review is due on the 25<sup>th</sup> November.
- TA noted that is a very important point that if we don't speak to our local MP's nobody else will
- PF asked about attending their surgeries. Other members recommended inviting them into the centres to see the importance of them
- TC advised that you let them know what schools have visited or will visit your centre.
- PF noted that the 7<sup>th</sup> October was a key date for the Destination Space programme.
- TC noted that no conservative members would be available that week
- TA asked that anyone who is lobbying contact PF so that ASDC is aware of all the regional lobbying taking place and conversations with local MP's
- CB noted that it was important to build up this intelligence database
- BD noted that the best time of getting your MP is a Friday as the others days they are in London
